Notification Import Documentation Dutch Ports (*declarants*)

In accordance with the customs authorisation of the (ferry) terminal, containers and trailers unloaded in a Dutch port are to be placed in the Temporary Storage Facility (in Dutch: Ruimte voor Tijdelijke Opslag, or RTO). Upon removal or upon collecting a container, the (ferry) terminal, as a RTO holder, is required to keep records showing how the goods in question have been shipped and accompanied by which customs declaration(s).

To comply with this requirement, the party in the hinterland, for example a customs agent, carrier, shipping agent or importer, is expected to provide the necessary data electronically.

This manual aims to assist the relevant party in submitting the correct RTO document code + document number so that the container can easily be collected.
